### Minutes

- **I.** <u>Meeting called to order</u> at 9:32 A.M. Introductions were made of each LMSC Chair that was present. All other representatives were introduced.
- **II.** Tom Tripp presented the <u>financial report</u>; dues were not collected last year. The Treasurer's report was moved, seconded, and passed.
- **III.** Melissa Rinker reported on the <u>Zone Committee meeting</u>. The procedure for nominations of Zone Committee chair was reviewed. This next year the Zone committee will be working on nominations for elections of the Executive Committee. Elections will occur next year in Dearborn.
- IV. <u>Discussion of Coaches Clinics in the GLZ</u>. Nike has discontinued their Coaches Clinics. Central (Illinois) hosted a clinic. Michael Collins came and spoke. A nominal fee was charged. It was felt that the actual "coaches" part of the clinic was not well done, but that the practical, "in-water" experience was good. Video taping was not what the participants had anticipated that it would be. There was no avenue for evaluation of the clinic.

Future clinic suggestions for the GLZ include inviting Randy Nutt & Marcia Cleveland to come and do an open water clinic in conjunction with the National 2 Mile Open Water Championships that Indianapolis is hosting in June of 2001. Illinois will be hosting two coaches clinics. Advantages of these clinics were discussed, citing enthusiasm among swimmers

and coaches. A reminder was made that the SNOOPER camera is available for use.

- **V.** <u>Coordination of meet schedules.</u> Melissa will assemble all dates and put all meets on a calendar, distributed to all LMSC's.
- **VI.** <u>Marketing of each LMSC in Zone.</u> Mel Goldstein, spoke of his role as Public Relations National Sponsor Liason, and the desire to "bring back value" to individual members.

Example: Coupon given for a discount for a swimsuit, etc.

- \*\*MBNA Affinity Card, discussion. Promotion from within USMS. Also where the money goes back to from member purchases; no annual fee.
