# Proposed Changes to the Rules of Competition Adopted By the House of Delegates Dallas, TX -September 13, 2002

The House of Delegates adopted the following changes to the Rules of Competition.

### **UH1 101.2** p.14

.5 Finish – At the finish, .... The head may be submerged after the last arm pull prior to the touch, provided it breaks the surface of the water at some point during any part of the last complete or incomplete cycle preceding the touch.

# **U1 101.7.2** p.17

# 101.7.2 – Medley Relay

Four Swimmers on each team, each to swim one-fourth of the prescribed distance in the following order: first, backstroke, second, breaststroke, third, butterfly; fourth, freestyle. Rules pertaining to each stroke used shall govern where applicable. At the end of each leg, the finish rule for each stroke applies in each case.

### **UH2 103.11.3** p.31

**A** Be in position at the start to have an unobstructed view and shall start the watch at the instant of observing the visual starting signal. If the visual starting signal is not observed, the watch shall be started upon hearing the sound of the starting signal.

### **R3 104.5.1C** p 38

**104.5.1C—Heat sheets**—For pre-seeded events, heat sheets listing the name, age, club, seed time, and heat and lane assignments shall be made available to all swimmers at the time of registration.

For deck seeded events, entry lists listing the name, age, club, and seed time by time or age group, except relays, shall be made available to all swimmers at the time of registration. If, instead, the host chooses to make heat sheets available for deck seeded events, then the heat sheets for each day, except relays, shall be made available in the morning before those events are swum.

#### **R5 104.5.2**C p.40 Insert subsection and renumber

**104.5.2C Rotation of 800/1500 and 1000/1650**—The order of two distance events may be changed by agreement of the meet director and the Championship Committee.

### **R6 104.5.4**C(2) p41

**104.5.4C(2)**—**Relay entry deadline**—A relay may be entered until the day before it is scheduled to be swum. Participants therein must have entered the meet by the individual entry deadline.

### **R7 105.2** p.46

**105.2.3**-In order for a time to be valid for Top Ten times consideration, a minimum timing quality of two manual times, averaged per USMS rules (see article 103.12.4), shall be used.

#### R14 105.1 p. 45 Insert and renumber.

**105.1.5** Results from events conducted in pools that do not meet the *minimum* pool length requirement (minus 0.00M) shall not be acceptable for Record Applications or Top Ten submissions.

**R15** 105.1 p.46 Insert after 105.1.5 above and renumber

#### 105.1.6 Pool Certification

- A Record applications and Top Ten submissions will not be accepted unless certification of course length accompanies them or is on file with USMS or USA Swimming
- B Pool certification shall be reported on the USMS pool certification form.
- C Certification data need only be filed once unless structural changes have occurred since original certification

### **105.1.7** Pool Measurement

- A The exact length of the course, measured for all lanes by a steel tape or other acceptable measuring device in feet and inches and fractions of an inch, or in meters and centimeters, must be attested to by the person performing the measurements.
- B A statement of the conditions under which the course was measured must be included.
- C Where a moveable bulkhead is used, course measurement of the two outside lanes and a middle lane must be confirmed at the conclusion of the session during which the time was achieved.

# R16A 107.1 p.48 Insert and renumber

## **107.1 DEFINITIONS**

**107.1.3** [M<sup>†</sup>] Mandatory requirement except that facilities not meeting these requirements may conduct sanctioned events but the results of those events shall not count for USMS Records and Top Ten. Events conducted in these facilities must note that they are noncompliant in the meet entry information.

C **Dimensional Tolerance** Against the required length, a tolerance of minus 0.00 meter in each lane on both end walls at all points from 0.3 meter above (if the wall or timing pad extends to this height or to the top of the wall or pad otherwise) to 0.8 meter below the surface of the water is allowed. [M<sup>†</sup>]

#### R18 104.5.4D(1) p.42 104.5.4 – Entry Procedures D Entry fees

(1) A \$30 surcharge may be charged to be used by the meet sponsor to help pay meet expenses. If a meet host uses a five-day format, the host may charge \$38.

#### **B** Distance Events

(3) For any event 800 meters or longer, men and women may be seeded together at the discretion of the Championship Committee. Two-to-a-lane seeding shall not be used.

**R22** 104.5B p39 Championship Committee

### **B** Rotation of meet schedule

(1) In odd-numbered years, men's events will be odd-numbered. In even-numbered years, men's events will be even-numbered. On the distance day only, men's and women's heats may be alternated regardless of whether it is an even or odd year.

**R23 103.9.** P.29

#### **103.9 Recall Rope Operator**

The duty of the recall rope operator shall be to immediately, upon sounding of the false start signal, activate the quick release mechanism of the recall rope so that the recall ropes drops across the course.

**R 24 102.16.4** p. 26 Insert and renumber.

**102.16.4** Protests concerning interpretation of the rules in Part 1 of the Swimming Rules and the Glossary shall be submitted in writing (on paper or in an electronic file), within 10 days to the USMS Rules Committee Chair who shall issue a decision in writing (on paper or in an electronic file) within five 5 days of the date of receipt of such protest, unless notified by the USMS Rules Committee Chair that the issue must come before the entire Committee. The ruling shall be final and binding on all parties.

### **UA1 108.5.1** p.31 Add (4) and E designation

**E** For free style, breaststroke, and butterfly, a forward start shall be used. The referee, however, may allow modifications, such as the following:

(4) For breaststroke and butterfly after the start and after each turn, a swimmer who is unable to push off with the leg/s may perform one asymmetrical stroke to attain the breast position.
