ANNUAL REPORT

The Database Task Force has served in it's second year of existence as an over site and review committee for the development of the USMS Enterprise Database System. We continue to set the broad policy outlines of the implementation of the database through monthly conference calls and email discussions. It is expected that we will continue to serve in this capacity through the first quarter of 2004, at which time the responsibility for database development and maintenance will be turned over to web site administration. Following is a review of database development by Jim Matysek, USMS Webmaster/Information Technology Director and Database Project Administrator, and a compilation of action items taken during our meetings. A full set of meeting minutes can be viewed on the USMS web site at www.usms.org/admin/excom.

PROJECT ADMINISTRATOR'S REPORT

We have made significant progress on a number of database development projects this year and are currently in the planning or implementation phases for several other projects. We have been maintaining our focus on the big picture throughout the process and have implemented each of the pieces in a way that brings these formerly disparate database elements together.

One of the keys to enabling the integrated database was creating an easy method of importing the National Office registration files to the database. This feature and the new permanent swimmer ID have given us the ability to identify swimmers in every portion of the database that is implemented. Other areas that have been integrated into the database this year include the annual USMS awards and recipients, the USMS pool and long distance records, relay All American listings, and the national top ten listings. In addition to these, several key changes have been made to improve the on line entry system used for nationals and a new on line event check-in system has been created and used successfully for nationals.

The History & Archives RFP was executed this year and the development activities associated with it are underway. All of the data specified in the RFP has been converted and imported to the USMS database, and the current development activities are focused on creating web display and maintenance software for this data. Other development activities that are currently in the planning stages will integrate the usms.org e-mail aliases, the calendar of events, and the top ten photo gallery. We are also planning to roll out an on line event sanctioning application that will integrate with the calendar of events, the ability for LMSCs to offer on line registration, and will modify the on line entry system to enable it to be used for local events as well as national championships.

ACTION ITEMS

Minutes of 10/30/02

- 1. The committee agreed that, as we move forward with this project, we will need to consult our customers so that when a system is implemented, they will be able and agreeable to the changes in their operations. We need to resolve any potential problems before work is done.
- 2. The EC determined that the alternate bid process approved by the DB Task Force on September 2 was not presented to the House of Delegates at convention. The EC is, therefore, requesting the USMS

Board of Directors approve the alternate process. The committee **MSA** - That the time frame for the BOD to vote will be 7 days from the time of posting.

Minutes of 12/11/02

- 1. The Project Administrator presented a Database Foundation Document and the committee **MSA** to give conditional approval of the foundation document as a starting point.
- 2. The committee discussed setting up subcommittee discussion for #1) Swimmer Name and Club Affiliation Tracking and #2) Permanent Club ID and **MSA** That issues #1 and #2 will be combined and handled by the Swimmer ID Subcommittee.
- 3. The committee discussed setting up subcommittee discussion for #3) Member Login and Identification and **MSA** that issue #3 will be a topic that is referred to the Privacy Subcommittee.
- 4. The H&A RFP has been revised since the vote was taken in August. Carl and Patty suggested several changes to the posted RFP after which the committee **MSA** Approval of the amended RFP.
- 5. The committee **MSA** that Fritz Lehman be included on the DB Task Force as a technical resource.

Minutes of 12/18/02

- 1. Minor revisions were made to the RFP as a result of working on the Management Plan. The committee **MSA** to accept the revisions to the RFP as they appear above.
- 2. The committee then discussed the Management Plan and the naming of the Management Team for the RFP. The committee **MSA** to accept the H&A DB Management Plan as amended.

Minutes of 1/21/03

- 1. The H & A Management Plan was changed since the previous meeting and the committee **MSA** Approval of H & A Management document as amended.
- 2. The committee agreed to a 5-day extension of the bid deadline for the H & A RFP to allow additional bids to be presented.
- 3. The committee **MSA** to set up a conference call to allow all bidders to ask questions of the management team and, following the conference call, bidders be allowed to amend their bids.

Minutes of 2/26/03

- The committee agreed that in order for Top Ten information to be used in the Enterprise DB, it will be necessary for each swimmer listing to contain the USMS number. President Jim Miller asked Pieter Cath, Records & TT Chair, to devise a plan for the orderly conversion of our procedures so that the USMS number is incorporated in the data at the LMSC level prior to submission to the Top Ten Chair.
- 2. The committee discussed the report of the H & A RFP Management Team and separately approved the following action items from the report:
 - a. **MSA** That we accept James Merrill's bid for Phase I minus the cost of the upgraded APL licenses. [James Merrill extracted the data from the existing H & A database and exported it to an online database.]
 - b. **MSA** The web-side programming that will implement the DB will be done by the USMS Webmaster/IT Director and contractors should they be needed.
 - c. MSA That we accept Sarah Stevens as a second contractor for the web portion of the RFP.

Minutes of 3/11/03

- The committee determined that it would be necessary for us to purchase APL licenses as per James Merrill's original bid and therefore MSA - That we accept James Merrill's bid for Phase I which includes the cost of the licenses. [During the implementation phase it was ultimately determined that we did not have to purchase the licenses after all]
- 2. The committee discussed the subcommittee reports on administrative login, permanent club ID, and swimmer name tracking and passed the following motions:
 - a. MSA The report on administrative login from the privacy subcommittee.
 - b. **MSA** The report on the permanent Club ID from the swimmer ID subcommittee.

- c. **MSA** The report on swimmer name tracking from the swimmer ID subcommittee.
- 3. The committee discussed the formatting of the USMS# using the permanent Swimmer ID. A proposal has been submitted that would remove the prefix, making this a truly permanent ID number. The committee MSA that as we move forward, the committee consider any situations where we can separate the permanent portion of the swimmer ID from the variable portion for instances where we do not need the full number.

Minutes of 4/22 & 5/1/03 (2-part meeting)

- The committee disc used the implementation of the new Swimmer ID for the H & A conversion and MSA
 - that the project administrator use the new Swimmer ID in the H & A conversion and not propagate the
 use of the old H & A ID further than is necessary.
- 2. The committee discussed the wording of a letter that will be distributed to USMS leaders concerning tools that will be placed on the web site to assist the running of sanctioned events. A subcommittee was formed to make revisions.

Minutes of 5/29/03

- 1. It was reported that wording for the Sanctions letter was approved by email by both the DB Task Force and EC.
- 2. A decision was made to accommodate workout groups. Although these groups are not official USMS entities, it will be necessary to address their needs in our databases. The Project Administrator outlined a plan for handling workout groups which the committee agreed to as follows:
 - a. The committee **MSA** that we attempt to accommodate the need to handle workout groups in the online entry system for the purposes of scoring meets that use workout group competition. Hugh Moore and Jim Matysek were assigned the task of devising the methods for dealing with the workout groups. They will consult with the affected LMSCs to confirm that we have provided them with the tools they need and report back to the committee.
 - b. Workout groups will be provided free web hosting on the USMS web server, but only as sites that are subsidiary to their official club web site.
 - c. The USMS club website listing page is scheduled to be converted to a database-driven page. During that conversion, provision will be made to allow listing of multiple web sites associated with a single registered club to accommodate the workout group sites.

Minutes of 6/26/03

- 1. The committee discussed the elimination of the variable portion of the USMS# and:
 - a. **MST** to eliminate the variable portion of the USMS registration number starting with the 2005 registration year. The DB Task Force shall notify the user base beginning November 1, 2003 and periodically thereafter until the change has been implemented.
 - b. MSA that we start a discussion forum among key LMSC personnel (chairs, TT, registrars) to have a discussion online on the variable portion of the registration number." The vote was 8 Yes, 1 No.
- 2. The committee discussed the role of DB Task Force going forward and agreed that, once the major elements of the databases are implemented, there will be no more need for continuing into the future. The expectation is that the DBTF will continue in place through the first quarter of 2004.

Minutes of 7/30/03

- 1. The committee discussed the verification of USMS# in data that is presented for the Top Ten database and agreed that there would have to be some methodology used (manual or programmatic) to verify the data.
- 2. The committee discussed legislation that would be needed once online registration is implemented and agreed on an approach. Leo was tasked with coming up with the wording and consult with Rob Copeland, Legislation Chair.

- 3. The committee removed the motion from the table on the swimmer ID format and MSD to eliminate the variable portion of the USMS registration number starting with the 2005 registration year. The DB Task Force shall notify the user base beginning November 1, 2003 and periodically thereafter until the change has been implemented. The vote was 1 Yes, 8 No.
- 4. Since the committee voted to perpetuate the USMS# with prefix it was **MSA** that we make the check digit algorithm available to approved vendors after executing a non-disclosure agreement.
- 5. The committee agreed to discuss the development of software for the Top Ten Recorders. Pieter Cath is developing a set of specifications describing the requirements, which will be distributed to the DBTF.

FINANCES – PAST

The zone has a balance as of May 9 of \$744.27 held by USMS in the USMS account #2512. Since December 5, 2002, the only transactions in that account have been the deposit of \$769.27 on December 5, 2002, from the Colonies Zone's that had not been part of USMS accounting until then and a \$25 expenditure on May 2 for the Dot award.

The 2003 zone budget is \$100 registration, \$20 phone/fax, \$15 postage/mailing, and \$15 printing/copying.

FINANCES – FUTURE

1. Zone Rep reimbursement to San Diego: According to USMS, the Colonies Zone's \$744.27 balance will be used to reimburse the zone rep's transportation to Sad Diego. One half of a double hotel room will be reimbursed from the USMS Convention Committee accounts. The 2003 Colonies Zone budget in the USMS budget will provide the \$100 registration. Yes, the funding sources are a bit complicated.

Note: It is the zone rep's understanding that each zone balance will be use first to reimburse for transportation. If this is insufficient, the USMS budget will reimburse. This would seem to be inequitable in that the zones with smaller balances, such as the Colonies zone balance is not believed to be, will pay, on average, a lesser amount.

2. 2004 Colonies Zone Budget submitted to the USMS Finance Committee August 1: \$110 registration, \$20 phone, \$15 postage, \$15 printing/copying, and \$50 Dot award totaling \$180.

Time Meeting Called to Order: 12:13 p.m.

- 1. Introductions and Announcements. One delegate from each LMSC introduced the other delegates from their LMSC. Barbara Protzman distributed the directory of LMSC officers to each LMSC for corrections and updating. All LMSC officers should let Barbara know if their email address changes. Several LMSCs had announcements: Two more open-water swims are scheduled in September in the Mid-Atlantic area. Rutgers University is hosting the Colonies Zone Short Course Meters Championships on December 7-8 and Long Course Nationals in August 2003. Jim Miller asked that all committee volunteer forms be returned by the end of the convention and that all convention attendees fill out the convention evaluation form, focusing on how the block committee formatting worked. The Executive Committee remains committed to fostering communication between committees.
- 2. Zone report. Barbara reported on Zone activities in the past year. Rutgers hosted the 2001 SCM Championships and University of Maryland College Park the SCY Champs. SCY Champs conflicted with Y Nationals and we will try to avoid that in the future; however, it is difficult when the dates are locked in early and cannot be changed. The Zone is encouraging more facilities to bid for the Zone Championships so that they can be located in various areas of the Zone. The Colonies Zone web site has a new web master, Mark Hurley from Maryland. Jim Matysek will set up a Colonies Zone forum under the USMS Discussion Forums that will be used to facilitate Zone communications and the exchange of ideas. Barbara displayed an attractive mockup of Maryland automobile license plates with the USMS logo [also designed by Mr. Hurley]. (Click here to see the sample.) She encouraged other LMSC's to investigate the procedure in their own states.
- 3. Work Groups. The meeting split into three work groups: Awards, Zone activities, and Championships and met for about 25 minutes separately.
- 4. Awards. The Dorothy Donnelly service award was presented to Jeff Roddin from Potomac Valley for his outstanding work as PV registrar, PV secretary and for improving masters swimming in the Potomac Valley LMSC. The plaque will be sent to him from David Grilli. The Awards work group also encouraged all LMSCs to submit nominees for the award and made some minor revisions to the nomination form. August 1st is the deadline and the LMSC chairpersons should take responsibility for encouraging nominations. Forms for the Donnelly award will be posted on the Zone web site. Marcia Cleveland will write a summary of the current and prior award winners (Nancy Miller). Charlie Cockrell has the nomination form for Nancy Miller.
- 5. Championships. Discussed how to get more bids. The work group suggests that the Zone be considered three geographic areas: North, South, and Central. A rotation between the areas for the championship meets would be encouraged. For example, for 2003 SCM the Northern area would be encouraged to bid, especially since MIT has a brand new pool complex. If there are no other bidders for SCM, Rutgers is willing to bid. There was one bid for SCY Championships from George Mason University, April 11-13. George Mason is a fast pool and has hosted several masters meet each year, plus large age group meets such as the Speedo Sectional Championships. The meet will not conflict with either Y Nationals (projected for April 24-27) or USMS Nationals in mid-May. Other championships events in the Zone include the 2004 one-mile open water at Wildwood, NJ, sponsored by Delaware Valley and Johns Hopkins Hospital/Maryland Masters and the 10K sponsored by Metropolitan. This work group also discussed having a Dixie-Colonies joint championship as was done several years ago. If there is no LCM Nationals in 2006 (because of possibility

of World Champs in Indianapolis), 2006 might be a good year for a repeat. Another possibility would be the next time SCY Champs are scheduled on the West Coast.

- 6. Zone Activities. "Success Stories" covering membership retention, team development, successful clinic ideas, tips, and team activities that foster team camaraderie (such as club awards, dual meets, fun meets) will be posted on the Zone web site. Tom Lyndon from New England will solicit stories. There was agreement that the teams and workout groups are where the growth is and we should concentrate on incentives for teams & workout groups. Coaches can be used as the contact point. An area on the Zone web site will be designated for announcing clinics in the various LMSCs. The zone activities work group would like to support Zone swimmers at Nationals and bounced around some ideas about how to do that. One idea might be to keep Zone scores at Nationals (or LMSC scores at Zones). Having "home-stays" where swimmers would host other swimmers during championship meets is another idea. Jeff Roddin will start up a thread on the Zone web site about how to promote involvement/enthusiasm at Zone Championships (and Nationals). Another idea was to have sharing forums at convention.
- 7. Zone funds. Zone funds that were previously held in individual bank accounts will be transferred to the overall USMS budget lines; therefore the bank account number for the Colonies Zone funds needs to be given to Sally Dillon. Zone bills will be sent through the Zone rep to the USMS treasurer who will set up a budget line for Colonies Zone to be spent down.

Oceana Zone has 2 LMSCs, Hawaii and Pacific. As of June 21, 2003 has a combined registration of 9,079. Hawaii has reported 550 swimmers and 10 clubs and Pacific has 8,529 swimmers and 109 clubs.

<u>Pacific LMSC</u> has a full swim calendar in all courses for 2003. Many National and World swim records have been set this past year, and many with Top Ten Times in all courses.

Santa Cruz Masters again hosted both Short Course and Long Course Championships with approximately 800+ swimmers attending each meet. Thanks and congratulations to Joel Wilson and Paul Wrangell (Cruz) and all the supporting staff for well run meets.

Coaches Report: For the 2003 and 2004 seasons, the focus for the Pacific Masters Coaches Committee will be "EDUCATION AND COMMUNICATION". Put into work already this season have been scholarships opportunities for coaches to attend the annual Pacific Swim Coaches Clinic every January in Napa, and the upcoming ASCA World Coaches Clinic in San Diego this fall. Both clinics provide presentations from the bestknown coaches within the entire swimming community and specific Masters tracks to address the unique needs of our sport. A one-on-one mentoring program is available for those coaches or teams that could benefit from some of **h**e more experienced coaches within Pacific Masters. PMS provides funding for a team to hire substitute coaches for their program as their coach shadows a mentoring coach at his program for a day, and a small stipend to the mentor coach.

Pacific Masters has taken a successful page from the USMS Coaches Committee and is adopting an on-deck coaches program for our regional championships. Other opportunities include observing and sitting in on swimmer/coach video assessments during the Walnut Creek Masters Intensive Training Camp in March, and being involved in the quarterly PMS Coaches Retreats where ideas can be shared and concerns can be heard. We hope this will develop into one of our more promising ventures. Pacific will be represented by 21 delegates and 6 automatic delegates at Convention.

<u>Hawaii LMSC</u> reports with pride that Janet Renner was nominated for the Scotty Schuman Award, given out by the Honolulu Quarterback Club. The award went to Al Minn, long time coach of Aulea Swim Club who recently retired. Diane Stowell is having shoulder surgery June 30th and wishing her a speedy recovery. ZONE ELECTION COMMITTEE REPORT – Lynn Hazlewood

The Executive Committee of United States Masters Swimming consists of five elected officers (President, Vice President, Secretary, Treasurer, and Zone Chair), the immediate Past President, and the Legal Counsel. Full details on the selection of officers and their duties can be found in the USMS Rule Book, Article 505: Officers. Each elected officer holds office for 2 years and may be elected to a second consecutive 2-year term. No officer may concurrently hold more than one office.

The Zone Committee acts as the Election Committee under the authority of Article 505.2.3. At the 2003 USMS National Convention in San Diego, CA, the House of Delegates will elect a President, Vice President, Secretary, and Treasurer. Advertisements for nominees appeared in the Fall 2002 Streamlines and the January 2003 Swim Magazine.

The sitting officers are eligible for a second term and were automatically nominated as of January 1, 2003. All current officers have declared that they will run for re-election. The nomination period from January 1 through March 31, 2003 passed with no other candidates nominated and the Election Chair declared the pre-convention nominations closed and the slate named.

Additional candidates may be nominated from the floor at the HOD meeting where the Election Committee presents it's report. If there are no further nominations, the slate will be elected by acclamation. If there are floor nominees, nomination and acceptance speeches will be offered and an election will follow at a subsequent HOD meeting.

Jim Miller Candidate for President

Why are you interested in this position and why do you believe you would be a good candidate? I came into the Presidency with a long term vision of the stature that USMS could have within the aquatic community. In order to achieve the leadership role that we should have nationally and internationally, we must first attend to the needs of our volunteers. One approach is through the Data Base Task Force, which aspires to place the entire organization on the same communication page. Whether the task is that of a local meet director or the national top ten recorder, this program will make their jobs infinitely easier.

Entering the data into the system in a format that serves all branches of USMS sounds so easy, yet is quite complex. Small data banks have developed both locally and nationally over the years. Some of the new data base requirements are viewed as being too stringent while others are not aggressive enough. Finding this balance is a challenge that I am in the middle of now.

I believe in our mission statement. Yet, a consistent approach to achieving its lofty goals has yet to be described. The core objectives that are before you at this convention represent the first step in that direction. As we pass resolutions, are these objectives being satisfied or are we off on a tangent?

We next must look to our leadership role internationally among masters aquatic organizations. The 2006 FINA World Championship bid is such a statement. My work is only partly completed, and I am dedicated to completing my vision with your help.

What do you consider to be the major issues facing USMS now and in the future. As a member of the USMS Executive Committee, how would you address these issues. A volunteer run organization such as ours needs to attend to the needs of the volunteer base. We need to serve them by networking all aspects of USMS under one communication umbrella. We must build a foundation for this to occur and allow all the committee work to proceed seamlessly. At the same time the privacy of the athlete must be maintained by providing blocks to all but those who need the information, based upon the position. As an example, the data needed by the LMSC registrar would be different than that needed by a meet director. This is just one aspect of service that we need to deliver to our membership.

Growth is important to my view of USMS. Any program that encourages adults to improve their level of fitness and improve their responsibility for their health is unique in this society. The aerobically fit adult athlete is a different creature than the average American adult. Their physiology is different as is their response to physical and emotional stress. We must get the word out and stimulate growth. We must have the infrastructure to support the growth, however. Thus we are giving attention to the flow of information. USA Swimming has just completed an exhaustive study of the governance of their organization. USMS needs to critically look at the contents of this report and decide upon the direction of the future leadership. The groundwork is being laid to look at those aspects that would be appropriate to our mission. The infrastructure must come first.

Please list any other experience that relates to your qualifications for office. My experience and positions within USA Swimming and FINA strengthen the role that USMS has within the aquatic family. I am currently a traveling national team physician for the USA Swimming Open Water team traveling to the last 3 World Swimming Championships. I chair the Asthma and Diabetes Task Forces. I sit on the Sports Medicine Committee for USA Swimming. I have just served as the physician overseeing the drug testing at the FINA Marathon Swimming Championships.
