#### Reports:

- Chair Catherine: Our Rules packet is due June 10 and in order to get the packet ready for the Annual meeting
  any rules changes need to be made at the April meeting. If OW and OW Safety subcommittees could look at the
  OW rules for any changes, additions or deletions in reference to the OW swims and safety.
- Surcharge OWNC, increase from \$3 to \$8
  - Swimmer surcharge Continue the discussion on increasing the swimmer surcharge for OWNC. The surcharge has been \$3.00 for least the last 10 years and at this point does not cover USMS costs on its monetary involvement in the events. USMS would not be making any profits, but the increase would cover the current costs. Jay can give further explanations on costs/involvement of USMS.
  - Sanction fee no longer exists. They were \$100 + \$5 per person, Open Water Nationals was an extra \$3 per person.
- Carter (our representative at the national office) is moving on from USMS. We wish him the best and he will be missed.
  - Bethany and Noni (membership staff) will be our new contacts. Jay and Angelique will still help.
  - They will backfill the role, but it will take some time.

#### **New Business:**

- Change to 1 Hour Virtual Championship Procedures
- Discussion of 5k/10k Long Course entry time period
  - o Does it need to be 4 months long?
  - Perhaps trying to shorten the time to 2 to 2-1/2 months, to when long course pools are usually in use (about end of May to middle of August).
  - Reason to shorten: some people feel it drags on too long. Promotion lasts the whole time, until the 3000/6000. Many people wait until the last few weeks to do this.
  - When the 1-hour event was shortened to January, participation increased.

- Stephen/Phyllis feel we should keep this going until at least Labor Day. Perhaps shorten a little, but access for some is very limited.
- Another thought Phyllis proposed was pushing out the start time for the 3000/6000
- o Catherine will get some additional data for our next meeting, and we can decide from there.
- Special instructions for USMS record attempt (discussion)
  - o Timer estimates distance in last partial lap, adds to previous total
  - Normally this is fine, but in the case of USMS records, the LDC does some calculations to verify those estimates
  - Takes the average time for the last several laps, make a ratio to estimate what the last final partial lap would be
  - Some members have said that they sprint in that last lap
  - This is only done for those who are in the running for a USMS record.

#### Goals: Old Business -

- 1. Develop a plan to increase the number of overall USMS sanctioned open water events. Clarify OW strategy between LDC and NO.
- 2. Continue to remove procedures from rule book
- 3. Look for more prominent venues for Open Water National Championships
